SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Move to fresh air. Keep at rest in a position comfortable for breathing. Call a Poison Centre or doctor.

Skin Contact

Wash with plenty of water. If skin irritation occurs, get medical advice or attention.

Eye Contact

Avoid direct contact. Wear chemical protective gloves if necessary. Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists, get medical advice or attention.

Suitable Extinguishing Media

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Evacuate downwind locations. Do not touch damaged containers or spilled product unless wearing appropriate protective equipment. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

It is good practice to prevent releases into the environment. Do not allow into any sewer, on the ground or into any waterway. If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas.

Methods and Materials for Containment and Cleaning Up

Stop or reduce leak if safe to do so. Contain and soak up spill with absorbent that does not react with spilled product. Cover the spill surface with the appropriate type of foam to reduce the release of vapour. Place used absorbent into suitable, covered, labelled containers for disposal. Flush spill area.
